2. ESSENTIAL QUALIFICATIONS :-

1. The candidate should possess a **Bachelor's degree** in any discipline from a recognised university or institution approved by the Govt of India. However the candidate may be permitted to take the preliminary examinations while studying for his degree. The candidate shall be required to produce proof of passing the degree course for being eligible to take the final examination during that year.
2. **Punjabi** passed in Matric Standard or its equivalent as on last date of receipt of applications i.e. 28-12-2009.
3. **Age shall be 21-35** years with relaxation for reserved categories as per Govt. Instructions mentioned below:-
 - (i) Provided that in the case of Punjab Police Service, a candidate should have attained the minimum age of twenty-one years and should not have attained the age of twenty-eight years as on 1-1-2009.
 - (ii) However in the case of candidates belonging to Scheduled Castes and Backward Classes of Punjab the age is relaxable upto 5 years as per Punjab Government Instructions including the Punjab Police Service.
 - (iii) The upper age limit for a Punjab Government employee, including that of a court, who has not less than four years continuous service under the Government, will be relaxable up to 45 years.
