

Subject:- Status regarding requisition of 265 (Two Hundred & Sixty Five) posts of Lecturer (College Cadre) in the Higher Education, Department.

(A) 265 posts had been advertised by the Commission vide advertisement No. 01 on 4-4-08, but this advertisement has been challenged in COCP No.117 of 2009.

(B) (i) Besides para 'A' above, interviews in the following subjects have been stayed:

(iii) **The subject of Sociology is involved in CWP No. 13008 of 2008, although no stay orders have been issued so far.**

(iv) **With a view to avoid all legal problems in the selection of 265 College Lecturers for the Higher Education Department, the PPSC has asked two specific clarifications from the Department:-**

"(i) Whether any other cases, apart from the cases mentioned above, are pending in any court of law involving these 265 posts of College Lectures, to the best of the knowledge of the Govt.?"

(ii) The PPSC would also like specific directions regarding further action to be taken for the selection of candidates for those subjects which are pending litigation but are not under stay orders of the Hon'ble High Court."

(v) **Now, 40 (forty) posts of different subjects have been withdrawn by the Government vide its letter No.11/30/09-5E1/1051 dated 16-4-2009 which are as under:-**
